

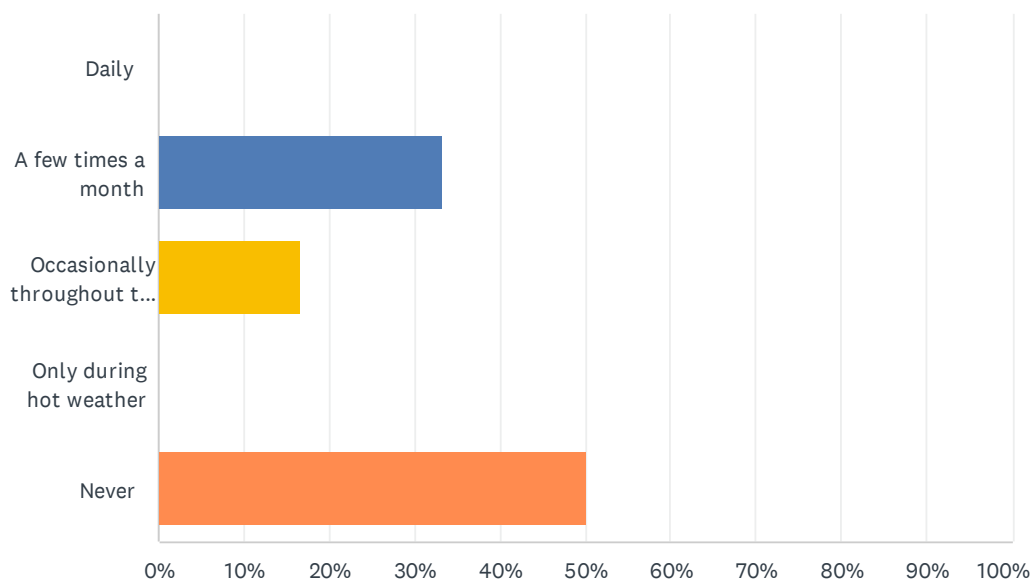

Q2 How frequently do you experience odor issues in your neighborhood?

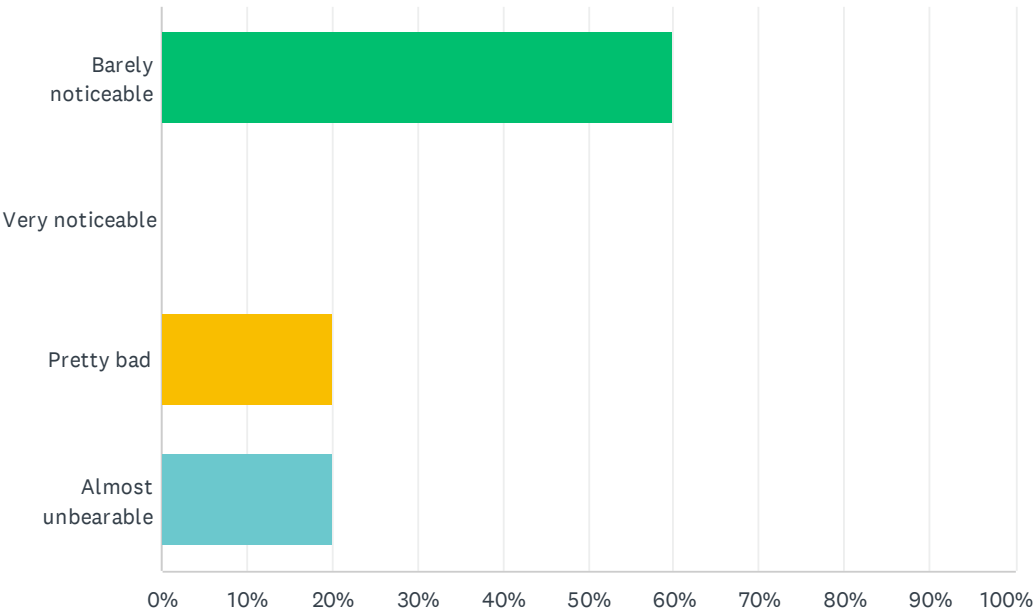

Q3 Typically, how strong are the odors you experience?

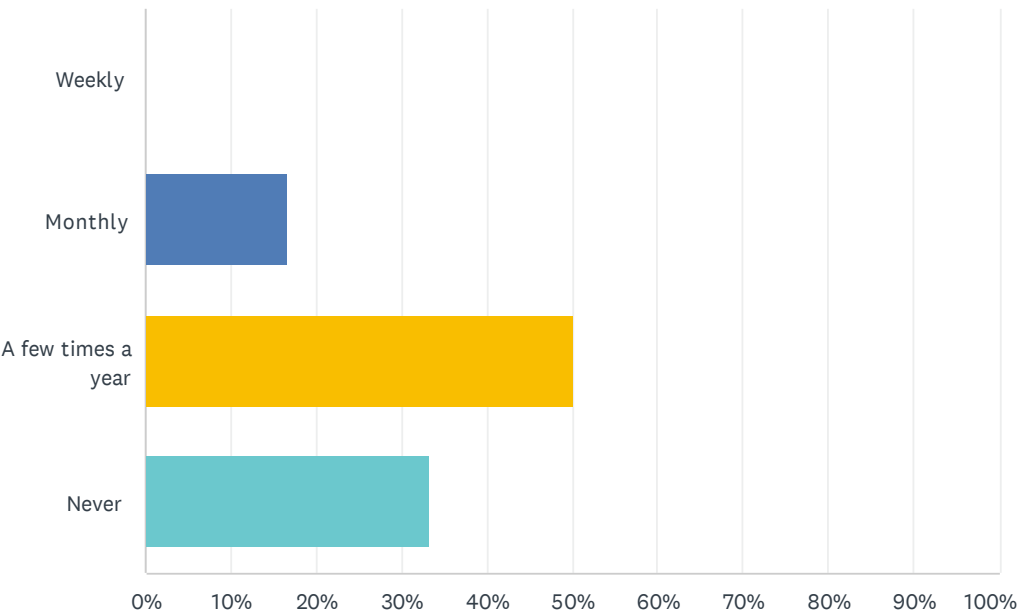

Q4 How frequently have you reported odors to MSD previously?

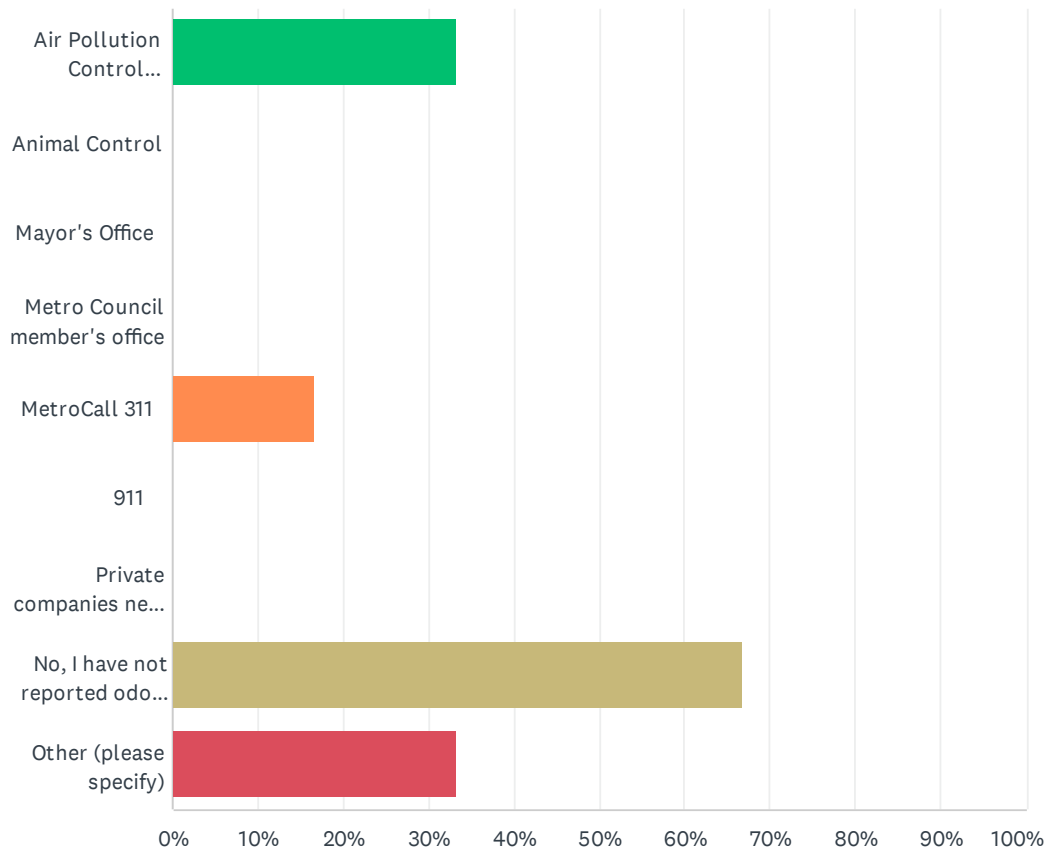

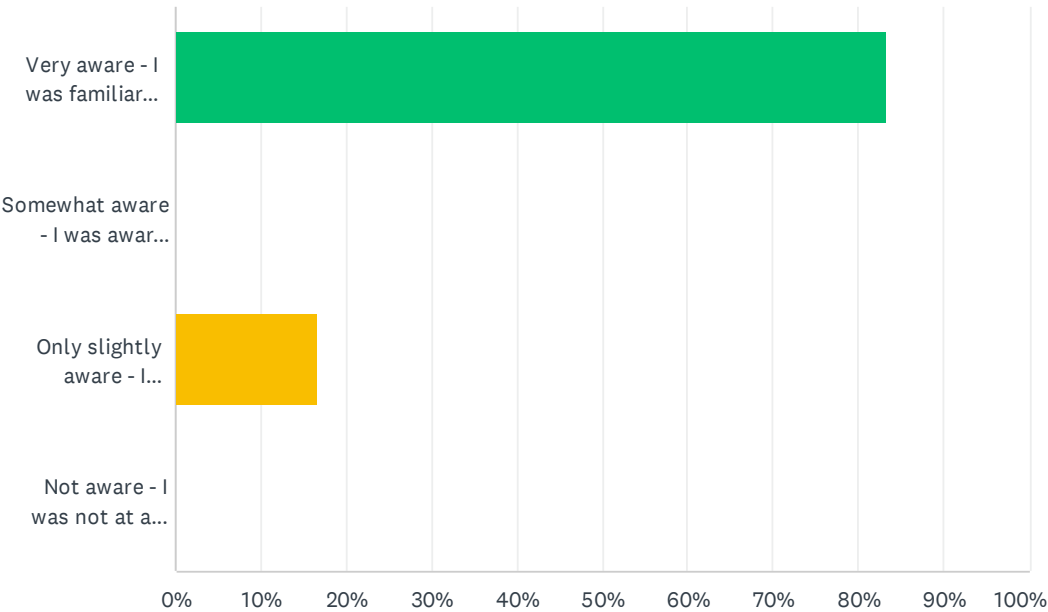

Q6 Prior to today, how aware were you of MSD's efforts to manage odors?

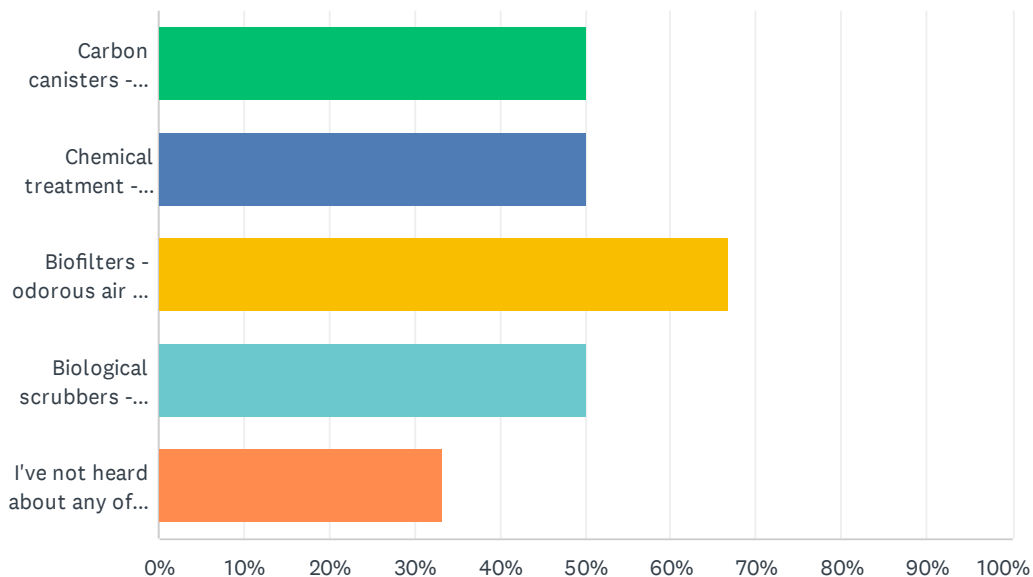

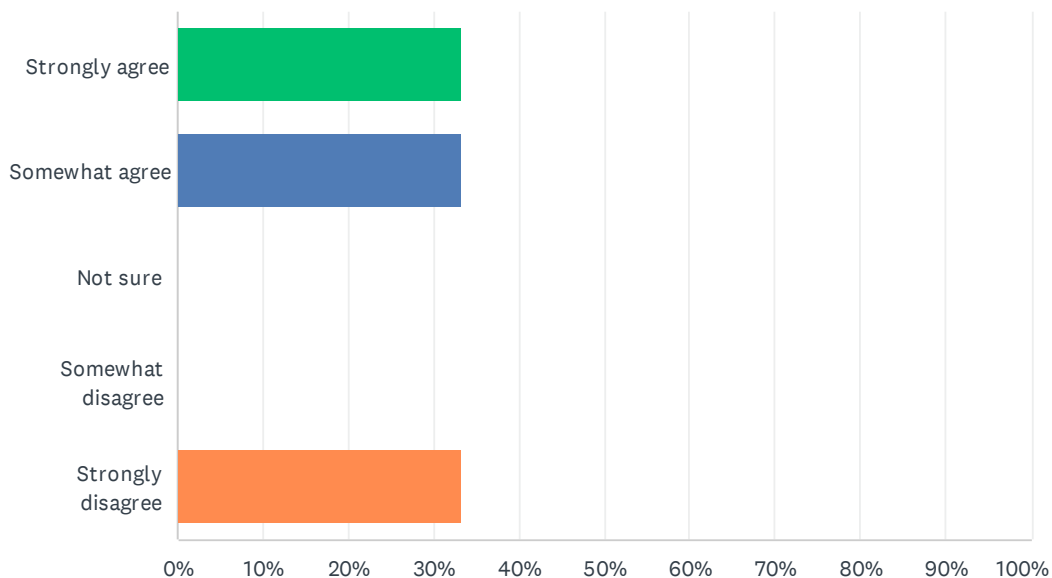

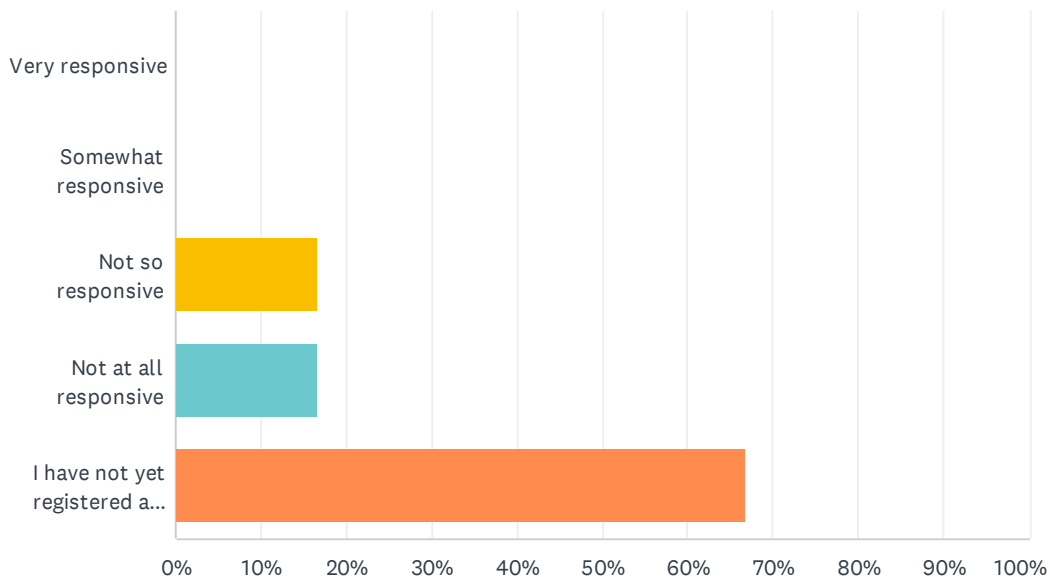
