“Through our Community Benefits Program MSD is ensuring that ratepayers benefit in more ways than one from our large-scale capital projects,” says MSD Executive Director Tony Parrott. “MSD vendors (contractor/firm) are encouraged to donate either financially or through their time to local non-profits and schools for workforce development, skilled-trade training, small business outreach and mentorship, or introducing youth to careers in the water sector.”

MSD defines “Local labor” as individuals who have a primary legal residence within Bullitt, Henry, Jefferson, Meade, Nelson, Oldham, Shelby, Spencer and Trimble counties in Kentucky; and, Clark, Floyd, Harrison and Washington counties in Indiana.

MSDJobLink.org is an online portal that helps contractors fulfill the MSD’s Local Labor Preference by connecting local workers with contract holders.
